



CLIENT'S CONSENT TO PROVIDE PERSONAL INFORMATION

PREAMBLE

- Whereas** the Protection of Personal Information Act, Act No. 4 of 2013 (hereinafter referred to as POPIA), came into effect on 1 July 2021;
- And whereas** POPIA regulates the collection, retention, dissemination and use of Personal Information as defined in POPIA;
- And whereas** Personal Information so defined relates to Personal Information of natural persons as well as juristic persons;
- And whereas** in terms of the company's relationship with you, your or the juristic person's Personal Information will be collected, retained, disseminated and used and published on social media for purposes of a competition;
- And whereas** the Company is considered a Responsible Party in terms of POPIA as the Company is collecting, retaining, disseminating and using Personal Information in the performance of the Company's duties in line with of its contractual relationship with you;
- And whereas** in terms of POPIA the Company is required to obtain your consent to collect, retain, disseminate and use your or the juristic person's Personal Information;

Therefore the Client hereby provides the required consent, and acknowledges that the Client has read the Company's Privacy Policy as published on its website, and indemnifies the Company against all and any claim which may be proven against the Company for the use of Personal Information, if utilised in terms of this consent.

TYPES OF PERSONAL INFORMATION COLLECTED, RETAINED, DISSEMINATED AND USED BY US

- The type of Personal Information collected, retained, disseminated and used will depend on the reasons for which it is collected, retained, disseminated and used. This may differ in due to various interactions with you or the juristic person may have with the Company.
- The Company will only collect, retain, disseminate and use Personal Information that it needs for that particular purpose and will collect, retain, disseminate or use no more Personal Information than necessary.
- You or the juristic person will furthermore be informed as to what Personal Information you need to provide to the Company and what Personal Information is optional.

CONDITIONS

The Company as a Responsible Party will process your or the juristic person's Personal Information in line with the conditions as stipulated in POPIA. YOUR RIGHTS

You, as the Client and Data Subject, have *inter alia* the following rights:

- The right not to share your or the juristic person's Personal Information with the Company. However, in such a case, the Company will not be able to offer you or the juristic person, its services and assistance, and you will not be able to enter into the social media competition.
- You may enquire from the Company which of your or the juristic person's Personal Information it holds, in which instance you may contact the Company at info@nexgro.co.za;
- You have the right to correct your or the juristic entity's Personal Information or to request the Company to delete your or the juristic person's Personal Information, unless the law states that the Company must hold the Personal Information;
- You have the right to revoke this consent;
