3. Act and Definitions

- 3.1 This Promotion of Access to Information Manual ("Manual") provides an outline of the type of records and the personal information it holds, and explains how to submit requests for access to these records in terms of the Promotion of Access to Information Act 2 of 2000 ("PAIA Act"). In addition, it explains how to access, or object to, personal information held by the Company, or request correction of the personal information, in term of paragraph 23 and 24 of the Protection of Personal Information Act 4 of 2013 ("POPI Act").
- 3.2 Definitions relevant to PAIA and this Manual, are set out in Annexure "A" annexed hereto.
- 3.3 The definitions are very important in terms of the interpretation of various aspects of this Manual and stipulated requirements. It is therefore of utmost importance to understand the definitions.

 - 10.3.2 The Requester (and if an agent is lodging the request, proof of capacity which must be reasonably satisfactory to the neXgro Group of Companies), including identity documents and power of attorney;
 - 10.3.3 The form of access required;
 - 10.3.4 The postal address of the Requester within the Republic of South Africa, or an email address of the Requester;
 - 10.3.5 If the Requester wishes to be informed of the decision in any manner (in addition to written to the address or email referred to in clause 9.3.5) the manner and particulars thereof;
 - 10.3.6 The right which the Requester is seeking to exercise or protect with an explanation of the reason the record is required to exercise or protect the right.
- 10.4 The neXgro Group of Companies may, and must in certain instances, refuse access to records on any of the grounds set out in Chapter 4 of Part 3 of PAIA, which includes but is not limited to:

- 10.5 Where a request is refused, a Requester may lodge a complaint in writing with the Information Regulator or apply to the High Court within 180 (one hundred and eighty) days of being informed of the refusal of the request, for an order compelling the record or records requested to be made available to the Requester or for another appropriate order. The Court will determine whether the records should be made available or not.

11. Prescribed Fees

- 11.1 The Information Regulator is responsible for administering the constitutions right of access to information.
- 11.2 It has published a "Guide on How to Use the Promotion of Access to Information Act 2 of 2000".
- 11.3 This Guide includes the fees payable by a Requester to enable access to information.
- 11.4 To ensure that the fees payable for a request are current, the Requester is referred to the Annexure "C" as The Information Officer, whose details are set out in clause 9.2 above, will assist you if required.
- 11.5 The following applies to requests (other than personal requests):
- 11.5.1 If the preparation of a record requested requires more than the prescribed 6 hours, a deposit shall be paid (of not more than one third of the access fee which would be payable if the request was granted);
- 11.5.2 A Requester may lodge an application with a court against the tender/payment of the request fee and/or deposit;
- 11.5.3 Records may be withheld until the fees have been paid.

12. Remedies

- 12.1 The company does not have internal appeal procedures regarding PAIA and POPI Act requests. As such, the decision made by the duly authorized persons in section 2, is final. If a request is denied, the requestor is entitled to apply to a court with appropriate jurisdiction, or the information Regulator (one established), for relief.

In this Manual and in terms of PAIA, unless inconsistent with or otherwise indicated by the context, the following words will have the meanings assigned to them:

1. **FAIS**
FAIS means the Financial Advisory & Intermediary Service Act, Act no. 37 of 2002;
2. **Information Officer**
The designated compliance officer appointed by the neXgro Group of Companies from time to time, to address compliance with PAIA.
3. **Information Regulator**
4. **The Information Regulator established in terms of the Protection of Personal Information Act, 4 of 2013 and whose contact details is provided in Clause 1.50.**
5. **The neXgro Group of Companies**
Any or all of the companies falling within the neXgro Group from time to time, currently consisting of *inter alia* the following:

6. Personal Information

- 6.1. Personal information is any information that can be used to reveal a person's identity.
- 6.2. Personal information relates to an identifiable, living, natural person, and where applicable, an identifiable, existing juristic person (such as a company, close corporation, trust, association), including, but not limited to information concerning:
 - 6.2.1. race, gender, sex, pregnancy, marital status, national or ethnic origin, colour, sexual orientation, age, physical or mental health, disability, religion, conscience, belief, culture, language, and birth of a person;
 - 6.2.2. information relating to the education or the medical, financial, criminal or employment history of the person;
 - 6.2.3. any identifying number, symbol, email address, physical address, telephone number, location information, online identifier, or other particular assignment to the person;
 - 6.2.4. the biometric information of the person;
 - 6.2.5. the personal opinions, views, or preferences of the person;
 - 6.2.6. correspondence sent by the person that is implicitly or explicitly of a private or confidential nature or further correspondence that would reveal the contents of the original correspondence; the views or opinions of another individual about the person;
 - 6.2.7. the views or opinions of another individual about the person;
 - 6.2.8. the name of the person if it appears with other personal information relating to the person or if the disclosure of the name itself would reveal information about the person;
 - 6.2.9. Personal Information concerning a child.

7. PAIA

It is the Promotion of Access to Information Act, Act no. 2 of 2000, as amended from time to time, together with regulations promulgated in terms thereof.

8. This Manual

This Manual means this manual as set out herein, together with all its Annexures, as amended from time to time.

9. Requester

Requester means any person (or a person acting on behalf of such person), including, but not limited to, a public body or an official thereof, making a request for access to a record.
